**OSURA** Board Meeting Minutes

1. Review and Approval of Board minutes of Friday, December 1, 2023.

A change on page three, f. changed to e. Motion to approve as changed by Tony Amandi and seconded by Gary Beach. Approved.

2. Budget and Finance – Bill Young

Bill presented statements for November and December 2023. Three new single memberships (@ \$20 each) were added to the General Fund in November; there were no expenses, leaving an ending balance of \$10,811.94. Furthermore, there were no credits or debits to the Scholarship Fund in November, leaving the account balance at \$16,944.83.

In December, there was no chance to the General Fund balance; however, the Scholarship Fund had an increase of \$650 from contributions, which minus OSUF fees on donations left an ending balance of \$17,554.93. Bill said to expect our 2023-24 scholarship awardees to draw additional dollars for winter term tuition and fees in January.

Finally, the OSURA Scholarship Endowment has a book value of 97,365.63 as of December 27, 2023.

## 3. Triad Funds

Joe Nibler gave a presentation on the history of Triad which began in1926. The organization held a weekly lunch and program and originally was all male administrators who were nominated to the group. In the 70's females were allowed to join and finally the faculty and staff. The nomination process was ended. Covid was hard on organization and they continued by zoom but no meetings since 2022. At peak membership was 50-60 but ended with about 20 and difficulty getting members to take leadership roles has increased. Scholarships ceased being awarded during COVID.

All this was by way of asking OSURA to administer the scholarship fund of Triad. Joe proposed the name Triad Service Scholarship be retained. Their scholarship was based on service and leadership and was for \$750-1000. A subcommittee composed of Gary Beach, Larry Pribyl and Mike Schuyler with Joe Nibler exofficio was appointed to propose a mechanism for OSURA to award a Triad Scholarship.

No scholarship applications have been received since the Jan. 1 opening date.

Mike asked Teri how the proposed online processing of the student applications (reading and ranking) will be handled. Teri suggested using Google Docs.
